ORDER

For good cause shown, it is this ____ day of _____, 2007, the Court hereby FINDS that Toni Locy is in CIVIL CONTEMPT of this Court's Order of August 13, 2007; and it is

FURTHER ORDERED that Ms. Locy is fined in the sum of \$1000.00 per day, payable to the United States, for each of the first seven days after entry of this Order during which she continues to fail to comply with the Order of August 13, 2007; and it is

FURTHER ORDERED that, for as long as Ms. Locy continues to fail to comply with the Order of August 13, 2007, the *per diem* fine payable by Ms. Locy to the United States shall increase by \$1000 increments according to the following schedule:

1. Beginning on the 14th day after entry of this Order, the fine shall be \$2000 *per diem*;
2. Beginning on the 21st day after entry of this Order, the fine shall be \$3000 *per diem*;
3. Beginning on the 28th day after entry of this Order, the fine shall be \$4000 *per diem*;
4. Beginning on the 35th day after entry of this Order, the fine shall be \$5000 *per diem*;
5. Beginning on the 42nd day after entry of this Order, the fine shall be \$6000 *per diem*;

6. Beginning on the 49th day after entry of this Order, the fine shall be \$7000 *per diem*;
7. Beginning on the 56th day after entry of this Order, the fine shall be \$8000 *per diem*;

and it is

FURTHER ORDERED that Ms. Locy shall accept neither solicit nor accept reimbursement or indemnification of any kind, now or in the future, for the amounts of any fines imposed under this Order but shall pay such fines, in full, from personal funds; and it is

FURTHER ORDERED that, unless this Court first receives notice from Dr. Hatfill that Ms. Locy has purged her contempt by obeying the Order of August 13, 2007, Ms. Locy and all parties to this case shall appear for a hearing on _____, 200__, at which point the Court will consider whether imprisonment is warranted to compel compliance with the Court's Order of August 13, 2007; and it is

FURTHER ORDERED that Dr. Hatfill shall, within 7 days of entry of this Order, submit to Ms. Locy a Bill of Costs for attorneys fees and expenses attendant to her deposition of September 10, 2007 and this contempt proceeding; and, it is

FURTHER ORDERED that within 7 days of receipt of such Bill of Costs, Ms. Locy shall either pay the same in full or file Objections to the Bill of Costs with this Court.
